Camp Tecumseh Rules and Regulations

Alcohol

Camp Tecumseh is Committed to providing a safe environment that is free from the use of alcohol, drugs, or controlled substances. Camp Tecumseh does not allow such substances on camp property. Violations of this policy may result in immediate removal from camp property and/or legal action.

Bicycles

Insurance restrictions prevent us from allowing the use of bicycles, scooters, skateboards, rollerblades and other similar equipment.

Fires

Camp Tecumseh does not allow ground fires anywhere on the property. All fires must be in either a pre-established campfire site (see staff for locations) or a portable, above-ground fire bowl. Camp Tecumseh does not provide portable fire pits or wood for personal campfires. There is a \$50 minimum fine for each incident of ground fire. Please help us preserve the beauty of Camp Tecumseh and the safety of our guests.

Insurance

Camp Tecumseh does not carry accident insurance for guests to Family Camp. All guests are expected to provide for their own insurance and care.

Misuse of Property or Equipment

The group will be expected to pay for any damages to the property and equipment beyond normal wear and tear. This includes, but is not limited to, graffiti, ground fires, structural damage, etc. There is a \$50 minimum charge for each incident of property damage. Damage charges include labor and materials.

Payment Information

All fees are due two weeks prior to your arrival date.

Quiet Hours

Please be respectful of others at camp and keep noise to a minimum after 10:00 pm.
